

## Game Gear Pty Ltd Terms and Conditions

### Game Gear Payment Policy

Payment options include credit card, bank transfer, cheque, eftpos (office) or cash. 5% upfront discount will be honoured for any order paid in full over \$4000.00 and any order under \$2000.00 must be paid in full. Receipt of this transaction must be submitted immediately to Game Gear. Any remaining payment is strictly due 7 days after the client has received their orders. 6%p.a late fees apply.

### Credit Card Policy

Game Gear accept Visa or Mastercard. A 3% surcharge on all transactions apply due to bank chargers. Credit Card transactions will not take place until authorisation has been confirmed from the owner of the card. A clear and readable copy of the Credit Card (back) and identification of cardholder (license) needs to be submitted to Game Gear within 14 days of the transaction. Should no valid copy of the Credit Card or identification be received the transaction will be cancelled and a 3% surcharge will be placed onto the invoice for the client. This payment then needs to be forwarded via cash, direct deposit or money order immediately, a \$30.00 administration fee will also be charged. Delays in Credit Card chargers are possible.

### Direct Deposit Policy

If paying by Direct Deposit, receipts for payment notification [remittance advise] must be submitted to Game Gear immediately after payment via email or fax. Orders will not be processed until this has been received. Cheques must be made out to Game Gear. If a cheque bounces, a \$20.00 administration fee will be invoiced on the total remainder invoice.

Requests can be submitted prior to ordering not after, this includes payment terms that are appropriate and realistic and will be approved by the discretion of Game Gear only. Accounts over \$10,000.00 can be placed on a payment plan, where a 20% down payment is required. No less than \$1000.00 per month on repayments. Late Fee - 20% of outstanding account will apply. ### Finance Conditions [Play Now, Pay Later]

20% deposit is required with confirmation of order. The order will not proceed without payment. 10 month payment plan follows with repayments follow strict guidelines of 10% of the rest of the order to be paid monthly. If full payment is not received within this term, late monthly fees will apply of \$100.00 or 1% of the remaining amount owed. Repayments must be received by the date given on the invoice or penalties will apply. A 3% surcharge will apply to each credit card payment - Refer to Credit Card Policy.
